- The exhibitors are not allowed to introduce its products if it has not paid everything Related to it's participate.
- Exhibits must not obscure the vision of neighboring and not affect on the rest of the exhibits in any way.
- Booths and exhibits must be properly displayed throughout the exhibition, and are allowed to transport any displays of the exhibition before the end and without a written agreement with the sector.
- authority of organizer in division and allocation of booths and the right for any reason (from the point of view) to change the overall design of the exhibition booth or a certain location, even if already appropriated for one company to be the company Approval to place alternative.
- Exhibitor have fully accountable for the cost of renovation of any part of the land or structure, which holds that happened to him any harm.
